

Enrichment Classes Policies and Acknowledgments

Registration: Peregrine School uses Active Camp & Class Manager ("Active") as our registration platform. Active charges 2.9% fee of the transaction. **Active fees are non-refundable.** Enrichment classes charge will appear as ACT*Peregrine School on your billing statement. On some credit cards (e.g., AMEX) charge may appear as ACTIVEWORKS ENDURANCE.

Cancellation/Late Enrollment: Enrichment Classes fees are non-refundable after <u>April 8, 2024</u>. Fees are non transferable. Peregrine does not prorate Enrichment Classes fees, nor do we allow students to take courses on a drop-in basis. <u>In the event of late enrollment, participants must pay the full course price and \$20 late fee.</u>

ProCare Sign-in/out: By registering my student in Enrichment Classes, I agree to use the ProCare app for attendance tracking. The penalty for not signing your student in and out at drop off and pick up is \$18/occurrence. Email extracurricular@peregrineschool.org for billing questions.

Grace Periods/Late Pick Ups:

<u>Peregrine students not enrolled in Kestrel Club (aftercare program).</u> Care from 3 pm to the start of their Enrichment Class is complimentary. There is a 10-minute pick-up grace period after the enrichment class ends. If a student is not picked up within this 10-minute grace period, they will be sent to Kestrel Club and will accrue Extra Hours charges (\$9/half hour) (based on Procare log).

<u>Non-Peregrine students</u> receive a 10-minute grace period before and after the class. Students picked up or dropped off outside of this grace period will incur a penalty of \$25/10 min per ProCare time stamp.

<u>All students</u> picked up after 5:30 pm will incur a Late Pick-Up penalty of \$25/10 min per ProCare time stamp.

Food Policy: Peregrine is a peanut and shellfish-free school. Foods found containing peanuts will be confiscated and will be subject to a \$20 fine per incident. We do not serve any foods that contain or may contain peanuts, tree nuts, or shellfish on the Peregrine Campus. If your student has a food allergy, please ensure the student food allergy and medical information are up to date on this registration form.

Vaccination Policy: Peregrine School requires all students to be vaccinated under the same requirements as the California School Immunization Law prior to their first day of class. If your student is not enrolled at Peregrine School during the academic year, you must submit studnet's Immunization Record as proof of immunization prior to their first day of class.



Publications: By registering my student in Enrichment Classes, I authorize Peregrine School to use Student's name, voice, signature, photograph, or likeness, in any manner, including, but not limited to, the School's materials, publications and promotions, published and distributed in any form, including the School website <u>unless stated to the contrary</u>.

Neighborhood Walk/Park Visit: Selected classes may take trips to nearby neighborhood locations e.g., (park, The Greenbelt etc.). These trips are always supervised by the Peregrine School staff.

At registration a parent/guardian is asked to give permission for their student to participate in neighborhood walks/park visits in the vicinity of Peregrine School.

Infectious Disease and COVID-19 policies: By registering my student in Enrichment Classes, I agree to accept and abide by the School's infectious disease procedures and protocols, including COVID-19 policies and protocols, which may be updated by the School throughout the School Year. The School's infectious disease policies may include but are not limited to pre-screening, testing, safety, use of personal protective equipment, quarantining and return to school protocols.

Acknowledgment and assumption of risks associated with exposure to COVID-19: I understand that COVID-19 is a highly infectious, life-threatening disease declared by the World Health Organization to be a global pandemic. COVID-19 is associated with a serious and potentially deadly condition called Multisystem Inflammatory Syndrome in Children (MIS-C). Further, I understand that the School has implemented safety rules and precautions in order to mitigate the spread of COVID-19. However, those measures do not completely protect against the spread of COVID-19. I acknowledge that even if I and Student follow all directions, instructions, and rules and exercise utmost personal care, there will remain a certain irreducible inherent risk to myself and Student, I accept that risk.

By registering my student in Enrichment Classes, I assume the risk that me or my student may be exposed to or infected by COVID-19 by entering the School's campus and that such exposure or infection may result in personal injury, serious illness, permanent disability, and/or even death. I further acknowledge that children who become infected with COVID-19 may later develop MIS-C, and I assume this risk.

I voluntarily permit my student to attend school in person and assume full responsibility for any and all risk of illness, injury, disability or death associated with exposure to COVID-19.

Disruption of school operations: I understand that a "Force Majeure Event" may necessitate a cessation of or change in all or part of the School's operations. A "Force Majeure Event" includes, but is not limited to, any fire, flood, act of God (earthquake, tsunami, volcanic eruption, hurricane, tornado, lightning, etc.), governmental action, or acts or threats of the



following: terrorism, epidemic, pandemic, viral outbreak, war, revolution, natural disaster, poor air quality, riot, strike, lockdown, or any event beyond the School's reasonable control, or that makes performance inadvisable, impracticable, illegal or impossible in the School's determination.

If a Force Majeure Event occurs, I understand that the School shall be entitled, in its sole discretion, to immediately and without notice: (1) extend, condense or otherwise modify the School Year; (2) change the facilities in which the School's educational program, including classes, programs, activities and events, ("Program") are held; (3) change the manner and format of the Program, including, but not limited to, changing to an on-line electronic format, independent or any other format or manner; or (4) postpone or cease all or part of its operations and its duties, obligations and performance under this registration. Further, I understand that Enrichment classes fees will not be refunded if the School's operations cease or are postponed, suspended or modified because of any Force Majeure.

Inclusion and Special Needs: We strive to accommodate every member of our community to the best of our ability. However, due to the short-term and dynamic nature of our Enrichment Classes, we cannot guarantee all forms of accommodation a child may need. Families with children who have special needs, learning challenges, and/ or disabilities should communicate with the Extracurricular Coordinator about whether and how accommodations can be made.
