**Application Deadline:** 5pm, Thursday, October 5, 2023.  
Late applications will not be considered.

**Required:**

- All vendors must have a *California Seller's Permit* (or *California Temporary Seller's Permit*). This is a free permit.
- All vendors must have a *City of Davis Business License*.
- If your business is located within the city limits of Davis, vendor is required to have a *Home Occupancy Zoning Permit*.

**Application Process:**

- Submit completed *Booth Application* to Peregrine South, 2650 Lillard Drive, Davis, CA 95618 or complete the fillable application posted at [www.peregrineschool.org](http://www.peregrineschool.org)
- Wait to be notified of entry status (typically 3 business days).

**How to Acquire State and City Permits:**

- The **California Seller's Permit** (or *California Temporary Seller's Permit*) is a free permit from the State of California. The entire process may be done online. This is a State of California requirement.
- Information about the **City of Davis Business License** can be found at Davis City Hall and online at [www.cityofdavis.org](http://www.cityofdavis.org). This is a City of Davis requirement.
- If your business is located within the city limits of Davis, you are required to have a **Home Occupancy Zoning Permit**. Information about the permit can be found at Davis City Hall and online at [www.cityofdavis.org](http://www.cityofdavis.org). This is a City of Davis requirement.

**What Happens After I Apply?**

Upon receipt of *Multicultural Arts & Music Festival Booth Application*, vendor's application will be reviewed. Please ensure the application is completed in full. Submission of application does not guarantee acceptance in festival. If accepted, the vendor will be notified no later than 2:00pm, Tuesday, October 10, 2023 via email and/or by phone. Most vendors will be notified of their status within 3 business days of applying. It is HIGHLY recommended to apply early.

**Fees & How to Pay:**

The booth fee is \$30 for the general public and for Peregrine School families, the fee is \$20. Fees may be paid by check or credit card, in-person during normal business hours at Peregrine School South Early Childhood Center & Elementary School 2650 Lillard Drive, Davis, CA 95618. Please **DO NOT pay fee until you have been notified of your status.**

**Please do not mail fee.** No vendor will be permitted to participate without complete payment of fee.

**Booth Spaces and Set Up:**

All booth spaces are 10'x10' and located on blacktop. All booth spaces have at least 2 sides with public exposure and most booths have 3 or 4 sides with public exposure. Booth spaces do NOT have power, heat or lighting and are subject to weather conditions. Peregrine is unable to provide tents, tables, chairs and/or help with set up/breakdown of booth spaces.

Vendors are encouraged to bring nonmotorized carts, as vehicles will not be permitted to drive to booth location for set up and breakdown.

**Day of Event Schedule (October 14, 2023):**

- 1 - 3:29pm - Vendor set up
- 3:30pm - All booths will be ready
- 4 - 7pm - Festival hours
- 7 - 9pm - Breakdown



**Cancellation Policies:**

In the event Peregrine School cancels the event, Peregrine School will issue a complete refund of booth fee. In the event of a vendor cancellation, Peregrine School shall not refund booth fee.
